These Terms of Service supersede and prevail, to the fullest extent permitted by the applicable laws, over any conflicting, inconsistent or additional provisions, specifications, rules, regulations, standards, proposals, undertakings representations and/or statements, either oral or written, by whoever made, that may refer or otherwise be applicable to the TelevisBlue system and the related services.

No other rights, privileges, conditions, representations, or warranties, expressed or implied, as to use of the TelevisBlue System and related services may arise from or in connection with the purchase (for use or resale), installation and/or use of the TelevisBlue System which are not contained in and regulated by these Terms of Services.

1. Definitions
